- Hazardous materials
- First Aid (minimum 6.5 hours every 3 years)
- Asbestos Safety: course approved by NYS Department of Health for “Operation and Maintenance” certificate.
- Annual refresher training optional.

Blueprints

- Elementary blueprint reading (electrical and mechanical)
- Advanced blueprint reading (electrical and mechanical)
- Sketching and layout

Mathematics

- Fundamentals of mathematics
- Shop math
- Estimating
- Using handbooks and reference tables

Industrial and Labor Relations (20 hours)

- History and background (6 hours, first year)
- Current laws and practice (14 hours, second year)

Trade Theory and Science

- Materials of the trade
- Hand tools and portable equipment
- Machining and machine tools
- Fundamentals of mechanics
- Inspection of tools and machinery
- Oils, lubricants, and coolants
- Gears, bushings, and bearings
- Plant layout
- Rigging and moving principles
- Installation of machinery and controlling auxiliaries
- Welding
- Fundamentals of electricity
- Power transmission equipment
